A. Consideration of Formal Ethics Complaint submitted by Americans for Prosperity - Illinois

Floor Opened For Public Comment

- a. Brian Costin presented the allegations contained in AFPI's Formal Ethics Complaint and AFPI's recommendations regarding discipline and corrective action.
- b. Commissioner Haupt recused herself from further deliberations regarding AFPI Formal Ethics Complaint upon learning of potential conflict of interest.
- c. Sarah Deen presented a request for the dismissal of individual Ethics Complaints Nos. 20, 21, 25, 26, 30 & 32 contained in AFPI's Formal Ethics Complaint.

Floor Closed For Public Comment

a. Motion made by Commissioner Patterson for Ethics Commission to find there

to be sufficient cause to proceed with a formal investigation into the allegations contained within the Formal Ethics Complaint filed by AFPI. Motion seconded by Commissioner Hicks.

- b. Debate by Commissioners on motion. In response to question posed by Commissioner Hicks, the Commission's legal counsel addressed: the scope of the powers and duties conferred on the Ethics Commission by the Rochester Public Library District's Ethics Ordinance; the Commissions authority to investigate alleged violations of state or local law; the Ethics Commissions authority to grant all of the relief sought by AFPI; the Ethics Ordinance's requirement that an ethics complaint be notarized; and, the Ethics Ordinance's failure to define "prohibited political activities" as used in Section 430/5-15 of the Ethic Ordinance.
- c. Floor Reopened for Public Comment to allow Brian Costin opportunity to respond to issues raised by Commission's legal counsel.
- d. Question called. Restatement of Commissioner Patterson's motion for Ethics Commission to find there to be sufficient cause to proceed with a formal investigation into the allegations contained within the Formal Ethics Complaint filed by AFPI. Vote taken.

Motion fails to pass due to deadlocked vote.

Floor reopened to discuss resolution of impasse caused by deadlock vote.

- a. Brian Costin suggests appointment of interim Ethics Commissioner needed to break impasse. Commission's legal counsel concurs.
- b. Sarah Deen advises that the Rochester Public Library District Board of Trustees is not scheduled to meet again until January but it is possible for the Board to schedule a special meeting for the purpose of appointing an interim Ethics Commissioner.
- c. Motion made by Commissioner Patterson to table issue of whether there is sufficient cause to proceed with a formal investigation into the allegations contained within the Formal Ethics Complaint filed by AFPI pending appointment of interim Ethics Commissioner. Motion seconded by Commissioner Hicks. Vote taken.
